#### What is a National node?


- A national liaison that brings together relevant national stakeholders in the country's health information system in a systematic way.
- Fosters discussion and collaboration at national and international level.
- NN shall encourage stakeholders to:
  - Share expertise at regional/national level
  - Share ongoing activities at regional/national level
  - Update on initiatives, meetings and expert groups at EU level





#### Structure of NN

- Structure depends on national organisation of HI stakeholders
- Core group: institutes mainly involved in population health information activities
- Two levels:
  - Those who work directly with data (e.g. research institutes).
  - Those who use data for policy and decision making.







#### **National nodes within PHIRI**

- Task 4.2: National node Coordination and Promotion
  - Lead by NIJZ (SI) and Sciensano (BE),
  - Partners: THL, CDPC, ISS, DGS/UNL, NIHD
- Objective: to promote and coordinate the sustainable network of national nodes
- Task 4.2 will encourage the set-up and further promotion of national nodes. This task will
  - coordinate the activities of national nodes,
  - building a catalogue of national nodes, their actors and their main activities, starting with a meeting of national coordinators.
  - The sustainability plan for further work of national nodes will be prepared.








- The milestones in the life course of PHIRI

# Tools to create a NN catalogue

- HIP section for NN is available.
  - More than 10 countries has been working on data entry since beginning of March.
- Manual with technical and methodological guidelines is prepared.
- NN coordinator shall prepare some information in advance, and then enter these information at the HIP.
- Necessary prerequisite:
  - Appointment of NN coordinator
  - PHIRI SharePoint credentials for persons who will edit NN at HIP.

Appoint coordinator(s) of NN: inform PHIRI on this decision by end of March 2021

Contact all national stakeholders



**Promote** NN in the country

Draft a structure of NN (secretariat, level I, level II, regional structure, etc)







